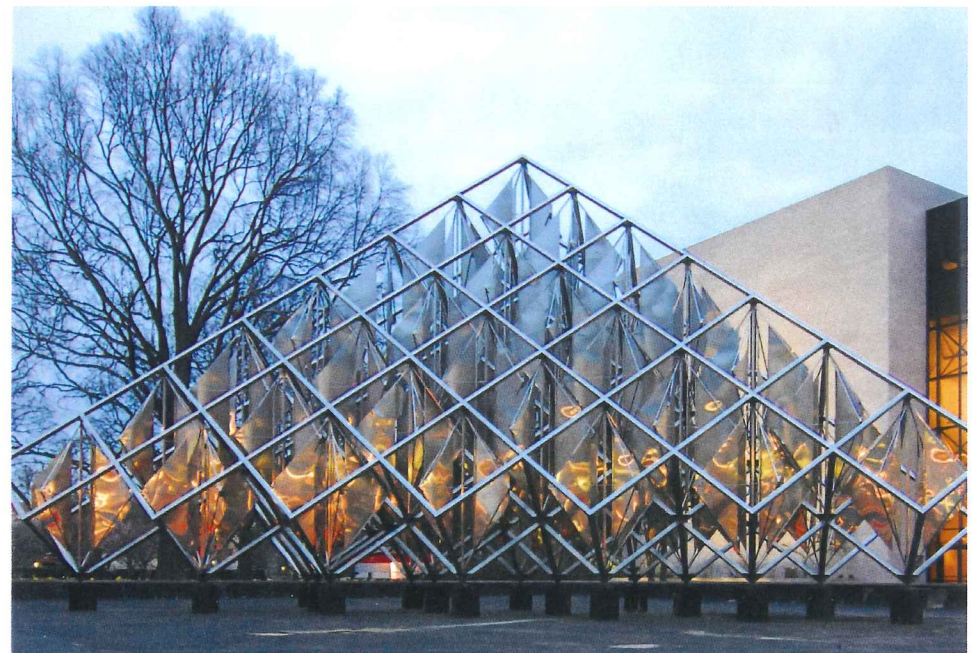

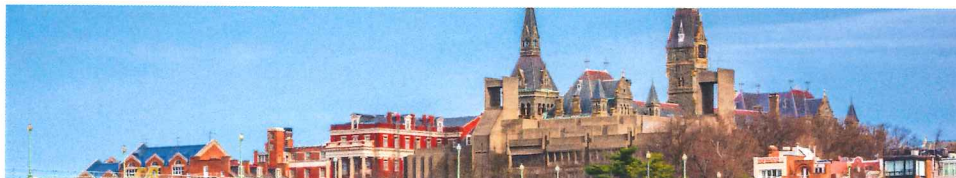

Helping Crime Victims Recover from Financial Losses

The financial stress resulting from crime is sometimes as devastating as the physical injuries and trauma victims experience. For many victims, restitution is the only means of recouping out-of-pocket losses sustained as a result of a crime. Even though courts may order people to pay restitution, there is no guarantee that the amount ordered will be collected. This can leave victims facing severe financial hardship, losing trust in the criminal justice system and feeling re-victimized. Hawaii has developed a national model — based on a partnership involving victim compensation, corrections, and parole — for improving the management of victim restitution. This session will explore the data-driven outcomes Hawaii has achieved using this multi-system approach and detail opportunities for attorneys general to lead similar efforts in their states.
